Classrooms, 1 no. Activity room, 1 no. Coordinator cum Staff room, 1 no. Auditorium & 2 no. Staircases are exist in the school premises.

FIRST FLOOR:-

At first floor there are 11 no. classrooms, 1 no. Art room, 1 no. Music & Dance room, 1 no. Coordinator cum Staff room, 1 no. Boys Toilets, 1 no. Girls Toilets, 2 no. Drinking Water &2no. Staircases are exist in the school premises.

The building is constructed with frame structure having RCC beams slab and 9" thick load bearing outer walls. The structure stability certificate has been also enclosed, which is issued by R.S. Yadav & Associates Chamber No.61, Typist Block, Civil Side, Tis Hazari Court, Delhi dated 20.02.2023. The fire NOC has been issued by the Assistance Divisional Fire Officer/Fire Station Officer, Fire Station Sector-15, Faridabad Memo No.FS/2023/169 dated 28.02.2023 valid upto 27.02.2026.
